<b>Company</b>	Silicon Valley Power, the municipal electric utility for the City of Santa Clara.

<b>How will I be billed?</b>	Your green power purchase will be listed on your utility bill as a separate line item. This charge is in addition to your regular utility bill.
<b>How will my bill be calculated?</b>	You will be charged an additional 1.5¢ per kWh usage per month for residential/small commercial or \$15 per 1000 kWh block for medium/large commercial and industrial. This premium is only charged on the energy (kWh) used and is in addition to all other fees and does not include charges for customer service and delivery. This purchase is in addition to charges by your electric utility and you must also pay all applicable federal, state, and local taxes and charges.
<b>How much will my total electricity service cost, including utility charges?</b>	Based on a monthly average usage of 500 kWh, the example below provides you an estimate of your 2014 monthly electricity bill if you receive service from Silicon Valley Power, and the extra monthly cost for <i>Santa Clara Green Power</i> . <b>Will my rates change over time?</b>	We expect the rates for <i>Santa Clara Green Power</i> to remain the same over time. We will notify you of any rate change in advance through customer communication.
<b>What sources will be used in my certified product?</b>	A blend of western wind (15%) and California solar (85%) resources.
<b>What happens if I move?</b>	If you move within Silicon Valley Power's service territory, you will need to re-enroll in <i>Santa Clara Green Power</i> .
<b>If I want to terminate this agreement/ contract, what is the early termination fee?</b>	You may cancel your enrollment in <i>Santa Clara Green Power</i> at any time with no fee by calling 408-244-SAVE (7283).
<b>What length of agreement/ contract is required?</b>	There is no required length of agreement or contract, you may cancel at anytime.
